

PAYMENT PLANS TERMS AND CONDITIONS

Terms and Conditions

This Payment Plan Agreement ("Agreement") is made by and between Somatic Experiencing® International ("SEI"), a Colorado registered 501(c)(3) nonprofit training and education organization having an address at 5303 Spine Rd., Suite 204, Boulder, Colorado 80301 and those who select the pay later payment option ("Registrant") upon registering and paying for an activity, program, webinar or conference ("Event") hosted by SEI.

By selecting the pay later option and submitting a payment method, Registrants accept this Agreement.

By choosing the pay later option, Registrant hereby agrees to pay:

- 1) The payment schedule processing fee;
- 2) The total tuition as stated on the Event registration page over the course of the scheduled payment plan according to the terms and conditions outlined below; and
- 3) Late fees of an additional \$25.00 if payments are received five (5) days after the payment's due date each month, for up to three months after the initial missed payment, with a maximum amount of \$75.00 to be collected in late payment fees.

SETTING UP METHOD OF PAYMENT

When selecting the pay later option you will receive an email with a link. Registrants must use that link to submit their preferred method of payment. <u>Your payment plan is not fully established</u>, <u>and you are not fully registered</u>, <u>until the payment method is submitted via this link</u>. The method of payment submitted will be used in all subsequent installment transactions of that payment plan. Please note that personal checks are not accepted and that only one Event is allowed per payment plan.

SCHEDULE OF PAYMENTS

Registrant agrees to complete the payment schedule when payment method is submitted.

Registrant will be officially registered for the event on the date SEI charges their payment method for the first successful payment. Payments will be deducted automatically from your submitted payment method over a seven month period, in equal amounts, on the same date as your initial payment.

To qualify for the early registration price, payment method and the first payment must be charged before the early registration deadline.

FAILURE TO PAY

Registrant understands that:

- a. Failure to make scheduled payments and to contact SEI within ninety (90) days after the initial missed payment will result in being sent to collections.
- b. Failure to repay this Agreement will bar Registrant from receiving their SEP(t) certificate until all outstanding debt has been paid in full. In addition to this, Registrant will also be unable to register for additional training modules.
- c. SEI retains the right to deny any Registrant's payment plan requests based on Registrant's past payment history with SEI.
- d. Failure to repay this Agreement shall be governed and executed according to the laws of the State of Colorado regardless of the place of its execution or performance. Any controversy or claim arising out of or relating to this Agreement shall be settled by arbitration in the county of Boulder, Colorado, in accordance with the rules of the American Arbitration Association. Judgment upon the award may be entered in any court having jurisdiction for this transaction.
